- 2. Overview of Project
 - a. Contract time: April 22nd, 2024 to October 25th, 2024. Earlier start may be permitted if award and contract documents are in place. Note Intermediate start and completion dates below.

 - c. Project Description Just under 310 miles of Striping, a combination of solid yellow, dash yellow, solid white, and dash white striping, and 72 point pavement markings.
- 3. Maintenance of Traffic follow MUTCD.
 - a. Contractor is responsible for all Maintenance of Traffic (See TP 5 in Specifications), i.e., flaggers, barricades, etc.
 - b. Barricades are to be checked daily at the beginning and end of each day, removed or reset if needed and promptly replaced if moved during the daily construction process
 - c. Unnecessary traffic must be kept to a minimum, work zone safety is paramount
 - d. Contractor is responsible for haul trucks and other subcontractors
- 4. Schedule
 - a. Completion date of October 25th, 2024 (Part 1 and Part 2)
